The following modifications relating to conditions of share linkage & collateral security to increase the lending under agriculture term loans by PACS/LAMPCS/SCS/FSCS and CCBs may be made in the respective provision(s) of the Bye-laws of the concerned societies/ banks as under, following due procedure.

A model provision for PACS/LAMPCS/SCS/FSCS and for CCBs, keeping in view the Government decision, is given below for necessary amendment of the respective provision(s) of the Bye-laws.
