DIRECTORATE OF COOPERATIVE AUDIT: ODISHA: BHUBANESWAR.

Order No.4237/XXA-Disc. Pro.-12/2011-Estt.-I

Date: 23.06.2017

Whereas a disciplinary proceeding under Rule-15 of OCS (CCA) Rules 1962 was initiated against Smt. Chandramani Mishra, Auditor of Cooperative Societies for certain act of omissions and Commissions committed by her during her tenure as Auditor of Cooperative Societies under Cuttack Circle, vide AGCS (O) Office Order No.2141 Dt.18.03.2008.

Whereas the disciplinary proceeding was served on Smt. Mishra, the delinquent Officer on proper acknowledgement on 31.03.2008.

Whereas the delinquent Officer has requested to supply her some documents vide her application dt.15.04.2008 and the Asst.A.G.C.S. Cuttack-II has supplied the required documents and intimated to Directorate of Cooperative Audit vide Memo No.1107 Dt.25.05.2008.

Whereas the delinquent Officer was transferred from Cuttack-II to Asst.A.G.C.S. Puri vide Order No.4401 Dt.10.06.2008 and joined in the Office of the Asst.A.G.C.S. Puri on 03.07.2008 forenoon .

Whereas the Asst.A.G.C.S. Khurda was appointed as Inquiry Officer and SAAGCS Cuttack-II (Office) appointed as Marshaling Officer vide Order No.5986 Dt.29.07.2009 in this disciplinary proceeding No.2141 Dt.18.03.2008 and whereas the delinquent Officer refused to receive Order No. 5986 Dt.29.07.2009 on 01.09.2009 in presence of the members of Office of the Asst.A.G.C.S. Puri, present in the Staff Meeting.

Whereas in modification to this Directorate Order No. 5986 Dt.29.07.2009 the Asst.A.G.C.S. Puri was appointed as Inquiry Officer and SAAGCS (Office) Office of the Asst.A.G.C.S. Cuttack-II appointed as Marshaling Officer vide Order No.2783 Dt.30.03.2010.

Whereas the Inquiring Officer i.e. Asst.A.G.C.S. Puri has fixed different dates for hearing the case but the delinquent Officer remained absent for which the date of Inquiry was published in the News Paper, i.e. 'THE SAMAJ' Dt.31.07.2011 fixing the date of hearing to 08.08.2011, but the delinquent Officer remained absent on the said date. Enquiry was conducted exparte.

Whereas the Inquiring Officer submitted the enquiry report vide Letter No. 109 Dt.09.01.2012 of Asst.A.G.C.S. Puri

Whereas the Asst.A.G.C.S. Puri issued a letter to Smt. Chandramani Mishra vide Letter No.3037 Dt.09.07.2012 as Smt. Mishra has been absconded from 04.09.2009.

Whereas notice was published in Local News Paper i.e. 'The Sambad Kalika' on 17.03.2013 to join duty but the delinquent Officer did not turn up.

Whereas the Asst. A.G.C.S. Puri has sent the enquiry report and 2nd show cause notice to Smt. Mishra vide Letter No. 1021 Dt.09.02.2015 by R.P with A/D which was returned unserved, but sent by her e.mail address was served. But the delinquent Officer has not given any explanation and continued un-authorized absence.

Whereas an additional disciplinary proceeding was initiated vide Order No.4669 Dt.28.08.2014.

Whereas the Memorandum for additional disciplinary proceeding sent to her Cuttack address through special messenger on 10.09.2014 could not be served as Smt. Mishra the delinquent Officer was not staying at her given address.

Whereas the Memorandum transmitted to her by e.mail address was received but the hard copy of Memorandum sent by R.P with A/D was returned un-served.

And whereas the notice was Published in Local daily Odia News Paper 'THE SAMAJ' dt.17.04.2015 to receive the additional disciplinary proceedings No.4669 Dt.28.08.2014 & enquiry report of the disciplinary proceeding No.2141 Dt.18.03.2008 .

And whereas the Asst. A.G.C.S. Berhampur was appointed as Inquiring Officer and the SAAGCS (Office) Office of the Asst.A.G.C.S. Puri was nominated as Marshaling Officer vide Order No.2797 Dt.05.05.2015.

And whereas the Asst.A.G.C.S. Berhampur fixed the date of Inquiry on 10.03.2016 and communicated the Order through Special Messenger on 14.01.2016 but the delinquent Officer refused to receive the notice. Similarly on 04.06.2015 the delinquent Officer refused to receive the letter No.30 Dt.02.01.2016 of Asst.A.G.C.S. Berhampur.

And whereas the notice was Published in 'THE SAMAJ' Dt.09.01.2016 to attend the enquiry but the delinquent Officer did not attend the enquiry & the enquiring was conducted exparte.

And whereas the Asst.A.G.C.S. Berhampur has submitted enquiry report vide Letter No.3448 Dt.21.12.2016.


And whereas the said enquiry report was transmitted to the delinquent Officer by e.mail vide Order No. 227 Dt.07.01.2017 of Directorate of Cooperative Audit and by R.P with A/D to her permanent address and her local address but both the letters were returned un-served. As such the notice vide Letter No.2098 Dt.24.03.2017 was published in 'THE SAMAJ' Dt. 27.03.2017 to receive the hard copy of the enquiry report of Asst.A.G.C.S. Berhampur vide Letter No.227 Dt.07.01.2017 and submit the statement of defence but delinquent Officer did not submit any reply.

Letter No. 2583 Dt.17.04.2017 i.e. the 2nd show cause notice for imposition of punishment was transmitted to the delinquent Officer by R.P with A/D but returned un-served. Hence the notice was Published in 'THE SAMAJ' Dt.21.05.2017 but the delinquent Officer did not submit any reply.

Now on consideration of the findings of the Enquiring Officers and other relevant records, the following Punishment is imposed upon Smt. Mishra, ACS by the Auditor General of Cooperative Societies, Odisha .

'She is dismissed from Government Service with immediate effect'.

The disciplinary proceedings No.2141 Dt.18.03.2008 & additional disciplinary proceedings No.4669 Dt.28.08.2014 are disposed of & closed.
