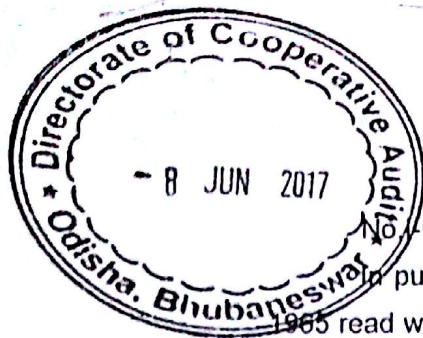

OFFICE ORDER

In pursuance of the provisions of Rule 60 of the Odisha Cooperative Rules, 1965 read with clause (I) of Sub-section (I) of Section 62 of the Odisha Cooperative Societies Act, 1962 (Odisha Act 2 of 1963), the State Government in Cooperation Department do hereby specify the audit cost structure and fix the rate of audit fees as in the schedule mentioned below to be paid by the different Cooperative Societies registered under the said Act for conducting the Statutory audit including special audit, re-audit and concurrent audit of their accounts for each Cooperative year or for any period specified in the order appointing the auditors for conducting such audit.

All the previous orders / notifications issued in this regard by the Cooperation Department, Government of Odisha are hereby superseded by this Order.

A. On engagement of Chartered Accountant(s) for audit of any Cooperative Societies , the audit cost will be decided basing on the number of days to be specified by the Auditor General of Cooperative Societies, Odisha for the concerned society as per the norms in that regard multiplied by the rate fees as fixed by above. Out of such total audit cost, the concerned cooperative society shall pay ninety five percentum thereof to the Chartered Accountant(s) and rest five percentum of the said cost to the State Government as per Order No: 5006/COOP, dated 07.06.17 of the Government in Cooperation Department. No extra remuneration like reimbursement of conveyance expenses, lodging expenses, Service Tax etc will be paid to the concerned Chartered Accountant(s) firms for the said purpose.

B. The number of maximum days required for audit of the different cooperative Societies shall be decided by the Auditor General of Cooperative Societies who may

decide the extra days to be required for audit of a particular society beyond the specified days after due consideration of the reasons for allowing such extra days . The time spent for audit shall include both drafting and typing /printing of audit reports.

C. Where concurrent audit of societies is conducted by the departmental Auditors on deputation, the audit fees shall be levied on the basis of number of days to be taken for final audit including its other branches/units where concurrent audit is not done.

D. Normally maximum 15 days time may be allotted to conduct special audit. In case of grave financial irregularities, the Auditor General of Cooperative Societies may allow more days after due consideration of the necessity for extra days.
