Sub:- Utilisation of Commission received on paddy procurement operation by  
PACS / LAMPCS.

Sir,

Primary Agricultural Cooperative Societies ( PACS /LAMPACS/ FSCS ) have been entrusted with the responsibility of paddy procurement as the Commissioned Agent of the Odisha State Civil Supplies Corporation Ltd., Bhubaneswar since KMS'2009-10. In recognition of the services provided by PACS i.e. providing infrastructure facilities, managerial, operational assistance etc., commission @ 2.5% of the cost of MSP of paddy is provided by Odisha State Civil Supplies Corporation. Commission to the tune of Rs.34.61 crore and Rs.31.70 crore had been released in favour of PACS for KMS'2009-10 & KMS'2010-11 respectively. It is expected that Rs.77.50 crore would be released to PACS for KMS' 2011-12 towards commission.

In course of review, it has come to my notice that detail of paddy procurement on behalf of Odisha State Civil Supplies Corporation have not been properly reflected in the books of account of PACS/LAMPACS. Commission due to PACS/LAMPACS have been retained at the District Central Cooperative Bank level without being credited to the PACS. Even, some of the District Central Cooperative Bank have adjusted the commission proceeds towards old outstanding dues of PACS.

In course of the High Level meeting on paddy procurement operation, the Secretary, Food & Public Distribution, Ministry of Consumer Welfare, Food & Public Distribution, Government of India had advised for utilization of commission released to PACS for development of infrastructure like construction of new godowns, repair of old godowns which would facilitate and strengthen paddy procurement operation at grass root level.

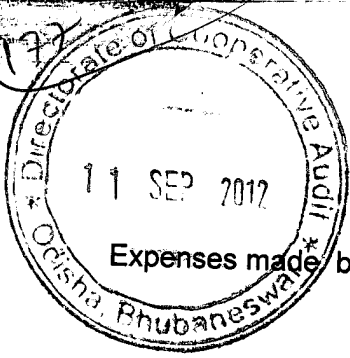
After careful consideration, it is ordered that the commission given to PACS /LAMPACS for paddy procurement operation should be utilized for development of infrastructure i.e. construction of new godowns of 50 MT- 100 MT storage capacity, construction of temporary shed for sitting arrangement for farmers during paddy procurement operation and expenses for installation of computers with internet connectivity for on-line farmers data entry. In case of expenses made under capital expenditure beyond Rs. 20,000/- ( Rupees Twenty Thousand ), prior approval of Registrar of Cooperative Societies, Odisha , Bhubaneswar should be obtained on the amount recommended by the Divisional Deputy Registrar of Cooperative Societies concerned failing which the expenses will be treated as illegal and subject to recovery.
